The parties hereby declare that they are familiar with the contents of the above documents and do not have any reservations regarding these documents. The aforementioned documents should be considered as mutually complementary documents. In case when any contradiction or discrepancy is disclosed in the aforementioned documents, the Employer, taking into account the order specified above, shall issue any necessary and binding explanations or instructions which shall not be treated as a change in the Contract Agreement.

2. In consideration of the payments which the Employer is supposed to make to the Supplier, the Supplier hereby undertakes to perform Supplies, including manufacturing, production or obtaining Supplies in another way, and to rectify all and any defects therein in full compliance with the provisions of the Contract Agreement.
3. 3. The Employer hereby agrees with the Supplier that the Employer shall pay to the Supplier after the performance of Deliveries and rectification of defects a lump sum/survey-based remuneration in the maximum amount of (in words:.....). In the case of Supplier's failure to perform all the Supplies specified in the Contract Agreement, the remuneration shall be reduced accordingly.
4. VAT will be charged according to the rules and regulations regarding this tax in force on the day of execution of the relevant part of the Works and issuance of an invoice.
5. This Contract Agreement was made in two identical counterparts, with one copy for each of the Parties.
